### **Exercise of Options Raises \$5.8 Million**

The Directors are pleased to advise that a total of 93,635,114 12 December 2019 options, each exercisable to acquire one fully paid ordinary share at \$0.05 per share, have been exercised by the optionholders, representing 81% of total BITOB Options on issue.

The remaining 22,451,353 BITOB Options have been subscribed for in accordance with the terms of an Underwriting Agreement, the terms of which are detailed in the Company's ASX announcement dated 8 November 2019.

The Company has raised a total of \$5,804,323 from the exercise of the BITOB Options.

This significant injection of funds will place the Company in a sound financial position as it focuses on achieving a commercial outcome following the successful phase 2 clinical trial of the Company's lead drug BIT225 for the treatment of HIV-1.

Beyond HIV-1, BIT225 is an important asset as it demonstrates the robustness of Biotron's approach to antiviral drug development and that the Company can generate clinically safe drugs with activity against a new class of viral protein targets. Funds raised through the exercise of these Options will enable the Company to advance the development of other promising compounds within its proprietary compound library that have been shown to have activity against other serious viral diseases including Hepatitis C, Hepatitis B, Dengue and others. In turn, this will enable the Company to attract a commercial partner for these applications within the Company's antiviral platform. The Company's Hepatitis B virus (HBV) program is showing particular promise, and proceeds from exercise of the Options will allow the more rapid development of this exciting new program.

In accordance with section 708A(6) of the Corporations Act 2001 (Cth) (Corporations Act), the Company gives notice under paragraph 5(e) that:

1. The shares will be issued without a prospectus disclosure to investors under Part 6D.2 of the Corporations Act.

  - (b) the Company has complied with section 674 of the Corporations Act; and
